Notice

1 Title

This notice is the Financial Markets Conduct (NZX Derivatives Market Rules) Approval of Rule Change Notice 2018.

2 Commencement

This notice comes into force on 20 December 2018.

3 Interpretation

(1) In this notice, unless the context otherwise requires,—

Act means the Financial Markets Conduct Act 2013

Derivatives Rules means the NZX Derivatives Market Rules

FMA means the Financial Markets Authority

Listing Rules means the NZX Listing Rules as amended and to come into force on 1 January 2019

NZX means NZX Limited

Regulations means the Financial Markets Conduct Regulations 2014

(2) Any term or expression that is defined in the Act or the Regulations and used, but not defined, in this notice has the same meaning as in the Act or the Regulations.

4 Approval of rule change

Pursuant to section 331 of the Act, the FMA approves changes to the Derivatives Rules provided by NZX to the FMA for approval on 13 November 2018.

Explanatory note

This note is not part of the notice, but is intended to indicate its general effect.

This notice approves changes to the Derivatives Rules that were provided to the FMA by NZX for approval on 13 November 2018. These changes will be incorporated into the Derivatives Rules on a date in the future as determined by NZX in accordance with the Derivatives Rules at Rule 1.5.1.

The changes approved are:

- the necessary amendments to ensure consistency with the listing rules; and
- the Capital Adequacy rules have been amended to include a “Fund” as well as Debt and Equity Securities.
